Dear Members of the Leesburg Community:

I am pleased to present you with the Police Department's 2012 Annual Report. The mission of the Town of Leesburg Police Department is to keep our community safe by providing the highest quality of police services. In 2012, Part I crime increased by 17 % led by a significant jump (46%) in shoplifting.

The major cause of our Part I crime increase was larceny; with the bulk of the increase being shoplifting and larceny from autos and most involving unlocked vehicles. The simple act of locking a car door or removing valuables from a car can have a tremendous impact on crime in our community. During 2012, we saw a dramatic increase in shoplifting with an alarming trend of Organized Retail Crime (ORC) groups targeting our large stores and malls.

During this year, our emergency preparedness and response plans were also tested. In June the area was hit by the Derecho storm, and in October Hurricane Sandy. While our community was spared much of the devastation caused by these two events, the department ramped up its operational tempo and was prepared to handle worst-case scenarios. 2012 was an election year and Leesburg once again became one of the focal points for the election, having visits from both presidential candidates, including the sitting President of the United States with less than 72 hours of notice and planning time, the department did an outstanding job in providing for security at events, and minimizing impact on the community.

The cornerstone of our success is the skill, dedication, and commitment of the men and women of this Department. These accomplishments reflect every member's strong commitment to our organizational values of Leadership, Pride and Dedication. I also want to thank the members of the Leesburg Citizens Support Team and the Leesburg Police Explorer Post for their individual and collective efforts, hard work, and contribution throughout the past year.

While our community remains a safe place to live, work, and prosper, we are starting to see some upticks in criminal activity. While the increases in property crime are areas of concern for us, we have developed and implemented strategies that we believe will allow us to quickly identify and react to crime trends. I know that I speak for every member of the Leesburg Police Department in saying that our success would not be possible if it were not for the strong partnership that we have with the Town leadership, other Town departments and most of all you the community. We pledge to continue to work with our partners to achieve our shared vision for Leesburg.



Working in partnership with the United States Secret Service, Virginia State Police, Loudoun County Sheriff's Office and the Town of Leesburg Public Works Department, the Leesburg Police Department assumed the lead role in planning and executing the operations for two large scale political rallies.





Unit Citation:

Recognition of acts by a unit/division/company demonstrating unusual judgment, ingenuity and/or personal risk and bravery during an emergency situation, when such action is beyond that normally expected in the line of duty

Ten Leesburg Police officers were recognized by the Loudoun County Chamber of Commerce for their actions after being dispatched to a life threatening situation. Sergeant Michael Buracker, Officer Matt Ash, Officer Joey Marsten, Officer Chris Mongelluzzo, Officer Alex Hilton, Officer Wayne Gray, Officer Chris Parker, Officer Jordan Helmer, Officer Brian Church, and Officer Carl Ford were awarded a Unit Citation for their life saving actions on January 9, 2012.

Just before midnight on January 9, 2012, Leesburg police officers responded to the 400 block of Foxridge Drive. It was reported that there was a man inside his home who had threatened to commit suicide with a handgun. When they arrived at the scene, the police officers were able to see the man inside the home holding a handgun to his own head. As the situation progressed, the officers learned that two small children were asleep in the upstairs bedrooms.

Their top priority throughout the situation was to ensure the safety of the sleeping children who were just steps away, blissfully unaware of the grave danger inside their own home. Eventually, the man exited the house with the loaded weapon still in hand, walking in the direction of several police officers. Clearly agitated and disturbed, the man pointed the weapon at his own head several times in the presence of the officers and threatened to take his own life.

Though greatly concerned for their own personal safety and for that of their colleagues, each of the officers involved remained calm and poised. One officer worked to engage the man in conversation and effectively kept him calm and focused. Eventually, the officer convinced the man to place the weapon on the ground and surrender, and he was taken into custody for mental health evaluation. When officers inspected the gun, it was determined that it was fully loaded.

With incredible composure and self-control, these Leesburg Police Officers successfully handled a very dangerous and life threatening situation, and did so while protecting lives and the safety of the subject, his family, and each other.





Citizen Complaints & Use of Force

During the calendar year 2012, the Police Department received seven formal complaints from citizens arising from more than 49,208 documented citizen contacts. In addition to the citizen complaints, the Department self-initiated eight complaints. An administrative investigation was initiated in each of the 15 cases. The complaints involved concerns such as improper application of law, improper application of Department policy or procedure, and allegations of misconduct. Following an internal investigation, sustained violations were found in four of the cases, and an employee was found to have violated Department policy and appropriate corrective action was taken. In the remaining eleven cases, the employee's actions were found to be correct or the complaint was unfounded.



2012 Use of Force Incidents




There were 41 Use of Force incident reports out of the 49,208 documented contacts that occurred in 2012 resulting in one suspect and four officers being injured.

Criminal Activity


During calendar year 2012, Part I crime increased by 17% and there were 20 more occurrences of violent crime than in 2011. Property related crimes, in particular larcenies and specifically shoplifting (46% increase), accounted for the largest categories of criminal activity in 2012. (* includes attempts.)

Criminal Investigations Section

The mission of the Criminal Investigations Section (CIS) is to conduct follow up investigation on felony complaints referred by the Operations Division and cases proactively developed by CIS personnel. The goal of CIS is to reduce crime within the Town by focusing its investigative resources on habitual offenders and felons by incorporating the Department's Intelligence Led Policing strategies.

CIS is organized into four units: General Assignment; Street Crimes; Forensics; and Major Crimes/Cold Case. Each unit has detectives assigned specializing in crimes against persons, property crimes, frauds, narcotic cases, and gangs. Additionally, detectives assigned to CIS hold certifications in forensic interviewing of children, crime scene processing, and evidence recovery from computers, telephones, and other audio and video devices.

During CY 2012, CIS personnel conducted 46 telephone and 55 computer forensic examinations. In addition, 11 crime scenes were processed.


Operations Division

The primary responsibilities of the Operations Division are to respond to reported criminal activities, conduct motor vehicle crash investigations, maintain consistent enforcement of traffic and criminal laws and work proactively to partner with the community in a joint effort to improve the quality of life in Leesburg.

Calls for Police Service: 2010 - 2012

Citizen calls for police service and officer generated calls totaled 49208 in 2012, a slight decrease from the 50832 in 2011. The Department strives towards efficient community policing and encourages the community to call the police for any suspicious activity.

Community Policing

The Town is divided into Community Policing Sectors. Officers are assigned to a Community Policing Sector and are responsible for handling any issues within that sector. The Town is also divided into Patrol Beats which incorporate the Community Policing Sectors so that the officers may patrol the areas that include their assigned sector.

The Community Policing Sectors are grouped together to form Community Policing Districts, which debuted in 2009 as the evolution in the Department's community policing/intelligence led policing philosophy continued. The Community Commander Program incorporates an assignment of a Commander,

at the rank of lieutenant, to organize and delegate assignments to the officers within the Community Policing Sectors inside of those Districts.


The Police Districts were re-vamped in 2012 from three districts to two districts. The area of the third district was divided and incorporated into District 1 and District 2. This decision was done in response to constant evaluation and review as to how well the system works and what improvements, if any, should be done as the Town grows and technology advances. This change was also driven by a system change incorporating emerging intelligence led policing strategies of the 21st century.

The Police Department utilized two district commanders who continued to provide oversight, guidance and direction in providing timely and effective police services within the respective commands. The former third district commander was reassigned as the Emergency Services Commander and tasked with refining emergency operations plans and training as well as honing the newly created Real Time Crime Center (RTCC), in line with the constantly evolving world of law enforcement.

The RTCC combines regional analysis, modeling, and forecasting that are then shared with the district commands to better deploy police resources in the interest of preventing crime, interdicting crime and being as proactive as possible, versus reacting to events after the fact. The RTCC uses the latest mapping and analysis technologies, combined with real world Leesburg crime (and quality of life issues) trends, to support the district commands and serve the citizens of Leesburg effectively.

The map shows the different Community Policing Districts and indicates the Commander for the various neighborhoods. From the Town's website one can click on the link to contact a Community Commander with questions and/or concerns for that district.

The email link is proving successful in providing a communication pathway for non-emergency questions, general information and for citizen feedback to the Police Department.

Crime and Traffic Accountability Program (CTAP)


The successful and award winning CTAP program continued to evolve in accordance with the implementation of the Community Commander Program and emerging technologies. This evolution has continued to enhance efficiency while improving information sharing and overall communication within the agency, by way of the RTCC.

The individual CTAP boundaries were updated and changed as development occurred and call for service trends and workloads were evaluated. Minor modifications to sector boundaries help to balance calls for service among the on duty officers and enhance response times.

Eighteen CTAP sectors are delineated and assigned to at least two officers who are monitoring and responding to quality of life issues and serve as first line contacts with citizens for non-emergency assistance, answering questions and being available to speak at Homeowner's Association meetings and business groups.




School Resource Officer Program

Since 1998, the Leesburg Police Department has had a police presence in the Middle and High Schools located within the Town of Leesburg. In 2012, officers were assigned to Smarts Mill Middle School, J.L. Simpson Middle School, Harper Park Middle School, Heritage High School, Loudoun County High School, and Tuscarora High School. In addition to their regularly assigned schools, each School Resource Officer (SRO) is assigned secondary responsibilities at elementary schools and specialty schools within the Town of Leesburg.

The presence of a School Resource Officer, armed and in uniform, ensures a timely response to any criminal behavior, or better yet, deters the criminal behavior from taking place. Students and faculty are better protected from violence and can pursue their educational activities in a secure and orderly environment. When requested, the School Resource Officer will instruct classes in such topics as crime prevention, substance abuse and driver safety. They also provide information on legal issues, and promote positive relationships and a better understanding between youth and police officers.

Many in the law enforcement community have realized the advantages of a close and positive working relationship with their local schools. Interaction among police officers, students, faculty and administrators helps to produce an understanding of the police officer's role and the criminal justice system. The Leesburg Police Department's School Resource Officer program seeks to maximize these advantages by placing officers in requested schools during all normal hours of school operation.

During the summer months when school is not in session, the SROs conduct several summer camps at the Police Department targeting elementary and middle school aged children. Topics of instruction during these camps include team building, leadership, conflict resolution, character education, physical fitness, juvenile law, and police procedures such as fingerprinting and evidence collection.



Operational Support Section

Traffic Management Unit

The Traffic Management Unit is made up of a sergeant and (4) four officers, including (2) motorcycle officers who perform a wide variety of tasks ranging from responding to traffic related complaints from citizens and local government officials, selective enforcement, parking complaints, traffic control, traffic checking details, and crash investigation and reconstruction. A large percentage of their time is committed to conducting traffic safety programs to make our roads safer.

In addition to their regularly assigned duties, members of the Traffic Management Unit are also responsible for the following:

- Special Events (Parades, marches, downtown events, funeral escorts);
- Community Speed Watch Program;
- Variable Message Boards and Speed Trailer deployments;
- Radar and Lidar (Laser) instruction at department and police academy level;
- Police vehicle calibrations:
- Child Safety Seat installations and inspections.

Members of the unit also serve on the Town of Leesburg's Standing Residential Traffic Committee and the County of Loudoun's Transportation Committee. In the 2012 calendar year, the four members of the Traffic Management Unit investigated <u>388</u> traffic crashes, issued <u>2410</u> traffic related summonses, and performed <u>156</u> child safety seat inspections.



Traffic activity at a glance.....2010 through 2012

- Overall 2012 crash statistics remained almost identical to 2011. Reportable crashes slightly decreased in 2012. There were 467 in 2012 compared to 450 in 2011. The number of injury crashes remained relatively the same. Hit and Run crashes increased slightly with 263 in 2012.
- There were 576 non-reportable crashes* during 2012, a decrease of 12 from 2011.

*A non-reportable crash as defined by Virginia DMV is a crash with less then \$1,500 of combined property damage and no report of personal injury. Crashes that occur on private property are also classified as non-reportable.



Leesburg Police Explorer Post #1041



The Leesburg Police Department Explorer Post #1041 was started in 2007. The Post now has thirteen active members. The Post continues to assist the Police Department at many public events including the July 4th Celebration, parades, foot races and National Night Out. Explorers have regularly assisted the Department with administrative projects that ranged from simple filing projects to sorting bicycles in the Town's impound lot. The explorers even provided "elves" for the ROCK Holiday party at Ida Lee. Explorer Post #1041 hosts the "McGruff" program, supplying the manpower to get McGruff to special events and assist the Crime Prevention Unit. Post #1041 also deploys the Department golf cart and a float at all the Town of Leesburg parades. The float is used to promote anti-crime and/or traffic safety topics. In 2012, the post also assisted with the Department sponsored "Holidays with the Cops" event. The post as a whole worked over 688 man hours working in the roles described above, providing community service, and completing training.

This past year, to show community support, members of LPD Explorer Post #1041 spent most of their weekend afternoons in October assisting the Arc of Loudoun. The Arc of Loudoun opens "Shocktober", a well known "premiere haunt", every fall as a fundraiser. So that the "Shocktober" volunteers could concentrate on managing the sprits of Paxton Manor, the Explorer Post managed the parking for the event working over 130 man hours in support of the Arc of Loudoun. 2012 was also the year that the post had the first of its members join the public safety field as a career. Captain Danielle Booth, while attending college, began working for the TSA at the Dulles International Airport. Booth still aspires to work as a law enforcement officer and is still an active member of the post.

Explorer posts help youth to gain insight into a variety of programs that offer hands-on career activities. Law Enforcement Exploring shows youth the ins and outs of the law enforcement profession. For young men and women who are interested in careers in the field of law enforcement, Exploring offers experiential learning with lots of fun filled, hands-on activities that promote the growth and development of adolescent youth.



Leesburg Police Citizens Support Team



In 2012, the Police Department and the Community continued to benefit from the dedication and support provided by the Leesburg Police Citizens Support Team. The Citizen Support Team is dedicated in its goal to support the Leesburg Police Department in its mission to protect and serve the citizens of Leesburg. The various ways the team assists the Department ranges from assisting at Town of Leesburg special events, community patrols, assistance at community events with the Crime Prevention Unit, data collection for the Traffic Management Unit, providing child identification/DNA kits to the public, pilot the Department's barrel train during parades and other child safety events, and when requested, perform traffic control at major fire or traffic accident scenes or after damaging storms. The Support Team is also the Department's partner in our "Holidays with the Cops" program. In 2012, the Citizens Support Team provided over 8000 staff hours of volunteer service, saving the Town over \$42,000 in staff costs. This year, the Team added "role player" to the list of ways they support the Department. Support Team members worked a total of 37 man hours acting as role players for the various special teams of the department. The Team has also spent over 503 hours working on administrative tasks for the Department. The number of hours worked by Team members in traffic control, special events, emergency call outs and proactive patrols totaled 7631 hours.



Giving back to the Community



Since the Department began hosting the "Holidays with the Cops "program, the event has gotten stronger with every year. In 2012, with the help of officers of the Department, Support Team members, and Explorers, over 5,000 dollars was raised to make the event successful. Ten children, identified with the help of ROCK staff, were taken shopping at Target with an LPD officer "partner" to help them with their shopping trip. This was right after the kids and their partners all had a chance to meet at headquarters and have dinner courtesy of Palio's of Leesburg.

This year, the "Holidays with the Cops "program received help from not only our police officers, dispatchers, and civilian staff, but also family members of Department personnel, Support Team members and Explorers. With the volunteer help, the support from Palio's, Target, and many other citizens and businesses, "Holidays with the Cops 2013" is already on its way to being a big success in its mission to give back to the community we serve every day.
