

Yard Waste, Brush & Leaf Collection

Yard Waste is collected curbside once a week, townwide, on Mondays, April through November. Yard waste (grass clippings, weeds, leaves, prunings and small twigs) should be placed in biodegradable paper lawn bags or loose in trash cans. Trash cans used for yard waste must have "YARD WASTE" stickers on them in order to be collected (request stickers via phone 703-771-2790 or email trash@leesburgva.gov).



Brush is collected year-round. Brush should be stacked loose at the curb by Sunday night and will be collected during the week, weather permitting. There is no set collection schedule. Each household may place one pile, up to 4' x 4' x 8', each week for collection. The following restrictions apply to brush collection:

- No branches or limbs larger than 6 inches in diameter or more than 8 feet in length
- No branches or limbs less than 4 feet in length
- No shrubs or trees with root balls attached or tree stumps
- No fencing, decking, pressure-treated lumber, or fire wood
- No leaves or garden waste

Fall Leaf Collection begins the 3rd week of October and runs through December. Leaves should be raked to the curb by Sunday night. Do not rake leaves in front of or into storm drains. Do not mix leaves with yard waste or other materials. There is no set collection schedule, but our goal is to make a complete sweep of the Town once every 5 to 7 business days during the season. Inclement weather or a heavy fall of leaves may slow collection times or extend the collection period. Visit www.leesburgva.gov/fall-leaves for more information.



Document Shredding Events

The Town hosts two free document shredding events each year, one in the spring and one in the fall. Residents may bring up to 3 boxes of papers to be shredded on-site at no cost. Visit www.leesburgva.gov/shredevents for more information and details of future events.

Street & Sidewalk Repairs

For any of the following problems, call the Streets Division at 703-737-7073 or email streets@leesburgva.gov:

- Street, sidewalk, or curb repairs, including potholes
- Trash or debris in roadway, including dead animals
- Damaged or missing street signs
- Streetlight outages

Nuisance Complaints

Under the Town Code, private property owners must maintain their properties in a safe and sanitary manner. Examples of unsafe or unsanitary conditions include:

- Tall grass and weeds exceeding 12 inches in height
- Standing or stagnant water
- Accumulations of trash or debris

Please note that Town staff cannot enter private property prior to notifying the property owner and allowing them time to respond before taking action to correct the violation. Private property owners are billed for the cost of any actions taken by Town staff.

Snow Removal

The Town removes snow from public streets and Town facilities. Communities with private streets, private parking courts, and HOA common areas are responsible for snow removal in those areas. Visit www.leesburgva.gov/snowremoval for a map of public and private streets and additional information about snow removal operations.

Property owners are responsible for clearing public sidewalks adjacent to their properties within 24 hours after the end of a snow or ice event.

The Town begins snow removal when approximately 2 inches of snow has accumulated on roadways. Primary routes will be cleared first, followed by secondary roads and then neighborhood streets. The Town operates a Snow Hotline (703-777-SNOW) during snow events for residents to report snow removal problems.

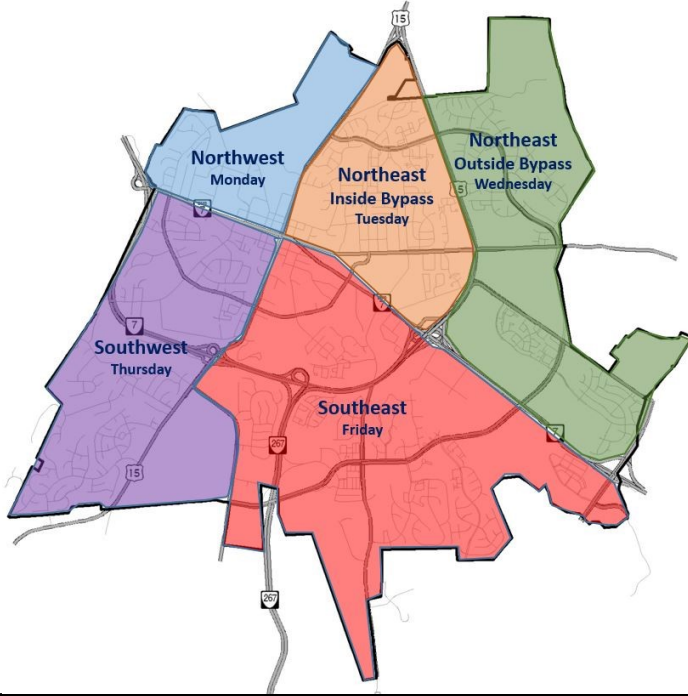

Trash & Recycling Collection

All single-family homes, townhomes, and some condominiums receive curbside trash and recycling collection. Trash and recycling are collected once a week, on the following schedule:

- NW: **Mondays**
- NE Inside the Bypass: **Tuesdays**
- NE Outside the Bypass: **Wednesdays**
- SW plus Meadowbrook: **Thursdays**
- SE except Meadowbrook: **Fridays**



Per Town Code, trash and recycling containers must be placed at the curb before 4 a.m. the day of pickup, but no earlier than 4 p.m. the day before pickup. They must be removed from the curblines within 12 hours of trash collection.

Each household is issued a black Toter® for trash and a blue Toter® for recycling. If your Toters® are missing or damaged, please call 703-771-6677 or email Patriot at leesburgsupport@patriotdisposalservices.com to request replacement or repair.

Recycling: What Can & Can't Be Included

The following items are accepted with household recycling:

- Mixed paper (newspapers, magazines, junk mail, office paper)
- Cardboard and paperboard
- Aluminum and steel cans
- Glass bottles and jars
- Plastics, No. 1 through 7

These items are NOT accepted:

- Styrofoam
- Aluminum foil and disposable foil pans
- Cardboard soiled with food
- Microwavable food trays
- Waxed-lined cardboard
- Plastic bags and plastic wrap
- Light bulbs, mirrors, and drinking glasses

Items should be rinsed of food residue.

Holiday Collection Schedules

There will be no trash, recycling, or yard waste collection on the following holidays:

- New Year's Day
- Memorial Day
- 4th of July
- Labor Day
- Thanksgiving Day
- Christmas Day

Collection will be shifted by one day for the rest of the week following a holiday.

Services will be provided as usual on other holidays, even if Town offices are closed.

Bulk & Oversized Item Pickup

Bulk item collections are made by request only. Call Patriot Disposal at 703-771-6677 to schedule bulk item collection and determine what fees may apply.

Accepted items include furniture, mattresses & box springs, appliances, water heaters, bikes, exercise equipment, and lawn mowers (gas and oil drained). Refrigerators, freezers, and air conditioners must have a sticker stating the item is Freon-free.



Construction debris (cabinets, wood, lumber, drywall, tile, roofing materials, siding, carpet, carpet padding, bricks, blocks, and landscaping timbers), or any materials weighing more than 50 lbs. or longer than 4 feet will incur an additional charge based on the material and quantity.

The following items **cannot** be collected as bulk items:

- Electronics
- Tires (on or off rims) and automotive parts
- Hazardous waste materials
- Tree stumps, root balls, branches, mulch, and yard waste
- Construction or landscaping debris generated by a contractor

Loudoun County Landfill

The Loudoun County Landfill, located at 21101 Evergreen Mill Road, accepts the following items (fees may apply):

- Antifreeze
- Batteries
- Electronics
- Fluorescent bulbs
- Motor Oil
- Paint
- Scrap Metal
- Tires

The landfill is open Monday to Saturday from 8 a.m. to 4 p.m. For more information and a full list of accepted items, visit www.loudoun.gov/landfill or call 703-771-5500.

Hazardous Household Waste (HHW)
