



# Yard Waste - CSI

The Town of Leesburg, through its **contractor (CSI)** for refuse and recycling collection, provides collection of yard waste to town residents and businesses receiving curbside refuse and recycling services.

**Collections occurs on the same day as your recycling collection.** (Thursday for SE, SW and Friday for NE, NW) **(From May through September, yard waste will also be collected on your trash pickup day).** Yard waste includes grass clippings, weeds and small trimmings from shrubs or bushes. When preparing your yard waste, please keep in mind the following guidelines:

## DO:

- Include grass clippings
- Include weeds (remove excess dirt)
- Include leaves
- Include prunings and small twigs (12-18" and under)
- Place in biodegradable **paper lawn bags** (available at grocery and home improvement stores) **or**
- Place loose in trash cans. Trash cans must have a **yard waste sticker\*** on them in order to be collected

## DON'T:

- Put yard waste in trash cans without a sticker.
- Use plastic trash bags or cardboard boxes.
- Mix with household trash or recyclables.
- Include sod, rocks or dirt. Grass with clumps of dirt attached will not be collected!
- Include large tree branches or limbs—please refer to “Brush Collection” for more information

If you have a contractor provide landscape services, you must make arrangements for the removal of any debris. # Brush Collection - Street Division

The Town of Leesburg, through the **Street Maintenance Division**, provides collection of brush free of charge to town residents and businesses receiving curbside refuse and recycling services. Brush is defined as **limbs or prunings from trees removed during normal maintenance by property owners. No call is required for brush pickup.** Because the Street Maintenance Division uses a chipper truck to grind the materials down, please keep in mind the following guidelines:

## DO:

- Include tree limbs **under 8' in length and under 6" in diameter** - but do not include clippings or prunings under 12-18" - see “Yard Waste”
- Place at curb line **Monday night—picked up Tuesday or Wednesday depending on route**
- Stack or pile

## DON'T:

- No stumps
- No fence posts
- No decking material or pressure-treated lumber
- No garden tool handles
- No vines, yard waste, or garden waste
- Do not leave ties or wires attached to limbs
- No root balls from shrubs or trees
- No rocks or dirt
- Do not mix with refuse, recycling or yard waste
- Do not block sidewalks
- Do not place brush in streets or in front of storm drains or other utilities

The Street Maintenance Division **does not collect debris from contractor landscaping services.** If you hire a landscaper to provide services, you must make arrangements with them for the removal of any debris or take the yard waste to the landfill.
