All members of the Leesburg Town Council are elected "at large." Town Council elections are held every two years, in November of even-numbered years. The Mayor is elected for a two-year term and the six Council Members are elected for four-year staggered terms. During each election cycle, the Mayor and three Council Members are elected and take office on January 1 of the following year.

Police Department Promotions

In January 2015, two lieutenants in the Police Department were promoted to captain, to fill vacancies left by staff retirements.

Captain Vanessa Grigsby is the commander of the Administration and Support Services Division. A graduate of the FBI National Academy, Captain Grigsby has been with the Leesburg Police Department since 1996. Prior to her promotion, Captain Grigs-



by served as the department's Criminal Investigations Commander.

Captain Carl Maupin is the commander of the Field Operations Division. Captain Maupin joined the Leesburg Police Department in 1994. He holds a Master's degree in Emergency & Disaster Management. Prior to his promotion, Captain Maupin was a Patrol Commander.



Both Captain Grigsby and Captain Maupin are graduates of the Police Executive Leadership School.

Sycolin Overpass Opens



Back in June 2013, construction began on the Sycolin Road Overpass across the Route 15 Bypass. While the closure of the at-grade intersection of Sycolin Road and the Bypass immediately improved traffic flow along the Bypass, the closure of Sycolin Road created significant, although temporary, access changes for the southeast quadrant of Leesburg.

On August 12, 2014— two months ahead of schedule! — the Virginia Department of Transportation (VDOT) held a ribbon cutting ceremony for the new overpass, restoring the transportation link between southeast Leesburg and the downtown.

The design and construction of the Sycolin Overpass was completed by VDOT, but the Town worked with VDOT and Loudoun County to secure funding and to coordinate the Town's project to widen Sycolin Road.



Public Safety

Policing Through Community Outreach

The Leesburg Police Department's approach to law enforcement is based upon building good relationships with the residents of Leesburg through community policing efforts. Leesburg Police Officers see themselves as the guardians of the community, not as enforcers. Some examples of community outreach programs by the Leesburg Police in the past year include:

National Night Out The intent of National Night Out (NNO) is to heighten crime prevention awareness and to strengthen police-community partnerships. In August 2014, the official Leesburg NNO location was the Exeter Clubhouse. At the event, children could enter a drawing for gift cards and coupons donated by local businesses including Target, Kohl's, Chick-fil-A, Giant, Wal-Mart and Cobb Theatre, by getting two police officers' signatures. Officers provided fun give-aways to children and crime prevention

and safety tips to their parents. The LPD Barrel Train gave rides, McGruff the Crime Dog handed out Junior Police Badges and the Leesburg Parks & Recreation Department sponsored a Moon Bounce and a tennis court game.



MotherNet Holiday Dinner For the 8th year, the Leesburg Police Department, the Leesburg Police Citizens

Support Team and Spanky's Shenanigans provided a

full Thanksgiving dinner to nearly 100 participants of INMED's MotherNet program for low income, single-parent families, at the Douglass Community Center.



Holidays with the Cops In partnership with the Leesburg Parks & Recreation Department's R.O.C.K. (Recreation Outreach to Community Kids) program, on December 12, 2014, Leesburg Police Officers gave 15 children from low-income families the chance to shop for holiday gifts. Each child received a Target gift card for \$200 and was accompanied to Target by their own personal shopping partner, a Leesburg Police Officer. Following the shopping trip, the children were treated to dinner at the Leesburg Police Department (provided by Palio's of Leesburg) where they also got help wrapping their presents to take home to their families.

Prescription Drug Disposal In May 2015, the Leesburg Police partnered with CVS Pharmacy and the Partnership for Drug-Free Kids to install a drug collection box in the lobby of the Police Department building, providing residents with a safe and environmentally responsible way to dispose of unwanted, unused or expired medications, including controlled substances. According to the 2014 study, more than 70% of teenagers report it is easy for them to get prescription drugs from their parents' medicine cabinets.

Town Achieves Coveted Triple Triple-A Bond Rating

Before the Town issues bonds to fund capital projects like the widening of South King Street, the Town receives bond ratings from three rating agencies, much like a consumer's credit score is checked before getting a mortage or auto loan. Municipal bond ratings range from "D," indicating the municipality is in default, to "AAA," indicating that the bonds issued will be considered prime investment grade bonds. The higher the bond rating, the lower the interest rate that the municipality pays, thus saving its tax-payers money.

Triple-A bond ratings are the hallmark of communities with strong, stable financial planning and management.

Since 2005, Leesburg has been rated "AA" by all three major rating agencies, with slight increases over the years. In July 2014, the Town broke through to the Triple-A level with a AAA rating from Standard & Poor's, prior to last year's bond issuance. Moody's and Fitch Ratings maintained the Town's rating at the Double-A level at that time.

In March 2015, prior to the FY 2015 bond issuance, the Town received upgrades from both Moody's and Fitch Ratings, to the Triple-A level.

The Town of Leesburg is the only town in Virginia to currently hold Triple-A ratings from all three major rating agencies.

Council Ends Pro-ration of Personal Property Taxes

When October rolled around last year, did you wonder why you didn't get a Personal Property Tax bill from the Town? Last year, the Leesburg Town Council made two changes to the Personal Property Tax collection process.

First, they moved the due date from October 5th of each year to May 5th. Second, the Council ended the pro-ration of personal property taxes.

In the past, if you bought a car in the middle of the year, you would pay pro-rated taxes based on the percentage of the year that you owned the vehicle. Similarly, if you sold a car in the middle of the year, your taxes would be pro-rated to reflect the actual time you owned the car.

Now, Leesburg personal property tax bills are based on the assessed value of vehicles garaged in the Town as of January 1st each year. The reason for the changes is to reduce staff time needed to process pro-rated tax bills, thus increasing the productivity of the Finance staff and ultimately saving taxpayers money.

As a bonus, Leesburg taxpayers received an unexpected "tax holiday" for 2014 on their personal property taxes!

K2M Announces Major Expansion in Leesburg

In December 2014, K2M, a medical devices manufacturer, announced plans to locate its global corporate head-quarters and research & development operations in the Oaklawn development in Leesburg. The \$28 million project includes construction of two buildings totaling 148,000 square feet (*pictured above*), the creation of 97 new jobs and the retention of 269 existing jobs.

K2M's global headquarters has been located in the Leesburg Airpark on Miller Drive for the past ten years, but when the company began looking for a location to construct their new facility, Leesburg was competing with other locations to keep them here.

Leesburg Economic Development Director Marantha Edwards worked hand-in-hand with the property owner, Loudoun County and the Virginia Economic Development Partnership on the successful effort to secure the project for Leesburg. Incentives included grants from the Governor's Opportunity Fund and the Virginia Investment Partnership.

Department Receives HUBZone Award

The Leesburg Economic Development Department was named the 2014 "Economic Development Agency of the Year" by the HUBZone Contractors National Council.

The Leesburg HUBZone received its designation on January 1, 2013, and has attracted 32 new companies since that time, creating 161 new jobs. An additional ten existing Leesburg companies have joined the program. Eighteen companies located in the Leesburg HUBZone have received HUBZone Certification to date, and several of the certified companies have been awarded federal contracts through the HUBZone program.

The Leesburg Economic Development Department works with a number of partners to promote the Leesburg HUB-Zone, including the Mason Enterprise Center, the Loudoun Workforce Resource Center, the Loudoun County Department of Economic Development, the Virginia Procurement Technical Assistance Program and the U.S. Small Business Administration. The collaboration with these groups has been the keystone to the success of the Leesburg HUBZone with joint efforts including seminars, site selection workshops, support groups, job fairs and counseling sessions.

Youth Career Expo Focuses on Entry-Level Jobs

Over 50 Leesburg businesses and 250 job-seekers converged on the ProJet Aviation Hangar at the Leesburg Executive Airport on Saturday, March 21, 2015, for the 3rd Annual Youth Career Expo.

The Expo focuses on career opportunities for recent college and high school graduates who are just entering the work force. There are many entry-level job opportunities in Leesburg and Loudoun County, but often younger workers

don't know where to start. The annual Youth Career Expo can help them get their foot in the door.

In addition to meeting face-to-face with prospective employers, this year the Expo also offered attendees a "dress for success" showcase and resume writing resources.

New Interactive Map of Land Use Applications



In October 2014, the Leesburg Planning and Zoning Department launched a new effort to keep residents and other stakeholders informed about requests to change the zoning, or allowed land uses, on parcels of land in the Town. The new online Leesburg Interactive Applications Map, known as LIAM, shows where each rezoning or special exception application is located. The map contains links to the actual applications and the staff reports that evaluate the requested changes based on the Town Plan and the Zoning Ordinance.

Now, if you see a yellow sign on a property in Leesburg indicating an upcoming Public Hearing regarding proposed development at that

location, you can go to the Town website (www.leesburgva.gov/liam) and view all of the information about the application. If you support or oppose the change, you can voice your opinion before either the Planning Commission or the Town Council.

Parks & Recreation

Two New Town Parks Opened

During FY 2015, the Parks & Recreation Department cut ribbons for two new parks in Leesburg:

Mervin Jackson Park

In February 2014, the Town Council approved the development of a public park on the site, named in memory of the late Mervin Jackson, former Leesburg Vice Mayor and Council Member. The new park wraps around the Log Cabin and encompasses the gardens formerly maintained by the Loudoun Museum.

Mervin Jackson Park features new landscaping, benches, drinking fountains for people and dogs, and paved walkways connecting the Loudoun Museum and the Town Hall Rose Garden with Loudoun Street.

The April 25, 2015, ribbon cutting ceremony included remarks by Vernith Jackson, grandson of Mervin Jackson, and the presentation of a commemorative plaque to Jean Jackson, Mr. Jackson's widow.

Potomac Crossing Park

In November 2014, Potomac Crossing Park opened in the northeast section of Town. Located at the end of Shanks Evans Road in the Potomac Crossing neighborhood, and backing up to Ball's Bluff Regional Park, the park totals eight

acres.

Approximately two and a half acres were cleared for the installation of a playground, picnic shelter and parking area. The remainder of the park is wooded open space. Paved and primitive trails connect to the trail network within Ball's Bluff Regional Park.

daily admission. Classes include cycle, step, strength training, Zumba, Pilates and yoga as well as choreographed interval training programs like Les Mills' BodyPump, R.I.P.P.E.D., and

TurboKick. Our instructors are certified and receive refresher training throughout the year.

The department strives to keep up with the latest trends in fitness training and adds new classes based on member interest. This past year, we added Barre classes that include ballet-inspired moves, PiYo which fuses Pilates, yoga and low-impact aerobics, and Power Punch that incorporates boxing and martial arts techniques. Instructors will help beginners modify exercises to fit their level, so there's no reason not to join a class!

The Leesburg Executive Airport is the second busiest General Aviation airport in the Commonwealth and serves as a reliever airport for Washington Dulles International Airport.

Leesburg Executive Airport Chosen as Test Site for Remote Tower Technology

In March 2015, the Leesburg Executive Airport entered into a partnership with Saab Sensis Corporation and the Virginia SATSLab (VSATS) to be the first airport in the United States to test remote tower technologies. The Virginia Department of Aviation and the Federal Aviation Administration (FAA) are advisory partners on the project.

The Leesburg Executive Airport does not have an air traffic control tower. In order to have a tower, the Town of Leesburg would be responsible for construction and maintenance of the tower. Construction costs could easily top \$5 million.

The remote tower will consist of a "crow's nest" of high definition video cameras, a pan-tilt-zoom camera and microphones installed on the roof of the airport terminal building. The cameras and microphones will send data to the remote tower center (RTC) which will be located inside the airport terminal building. The RTC will have a series of high-definition video displays showing a 360-degree view of the airport and a two-position controller desk. During the summer of 2015, FAA-certified control tower operators will test and evaluate the technology.

In addition to the cost savings over construction and maintenance of a traditional tower, remote tower centers for multiple airports could be located at a single facility, further reducing costs and improving staffing efficiencies.



Utilities

Sign Up for Automatic High Water Usage Alerts

Sometimes a spike in water usage is the result of taking out the "Slip n' Slide" for the kids on a hot summer day. But sometimes, a spike in usage can signal a water leak, running toilet or other plumbing problem that needs to be fixed. If the leak is in the underground water line between the water meter and your house, unless you notice a soggy spot in the yard, you probably won't know that you have a leak until you get your water bill—and it's much higher than you expected.

To help water customers avoid the unpleasant shock of an unusually high bill, or the expense of damage repair caused by an undetected leak, the Town's Utilities Department offers automatic high water usage alerts. Through the Town's website, customers can view their daily usage for the past several years and then determine a threshold of daily usage that, if exceeded, will trigger an alert via either email or text message. The Utilities Department uses the same high usage alert system to proactively identify possible water leaks or other problems for water customers. Since the leak



check program began in September 2014, staff has performed about 800 checks each quarter. So, don't be surprised if you get a call or a visit from a Utilities staff member to let you know you might have a leak and to help you check.

Utilities Maintenance Programs

Just as your home or car requires regular maintenance to keep it in good running order, so too does the Town's utilities system. Here are three annual mainte-

nance programs conducted by the Utilities Department:

Valve Exercising — During FY 2015, the Utilities Department began a new preventive maintenance program, known as a Water Valve Exercise Program. Utilities crews close and then reopen the valves on the water mains and service lines in a specific distribution area. The purpose of the program is to test the operation of the valves, ensuring system reliability.

Water Main Flushing — Each spring, the Utilities Department conducts its annual program of flushing the water system, with special emphasis on dead-end water mains. Water is moved through the water mains at a high velocity to create a scouring action. Water is then discharged through a hydrant. The flushing removes sediment and other material build-up from the pipes, thus improving water quality.

Water Meter Change-outs — All Leesburg water meters are equipped with automated meter reading (AMR) technology. The Town first began installing the AMR-equipped meters in 2002. The meter change-out program is an on-going program that replaces meters in ten-year intervals, ensuring that all meters have the same technology and meet industry standards.

Stay Informed About Trash & Recycling Collection Schedule Changes

The Town of Leesburg provides most residences in town with curbside trash collection twice a week, recycling collection once a week, yard waste collection twice a week from May through September and once a week during the other months, bulk item pickup once a week, Christmas tree recycling in January and year-round brush and fall leaf collection—all included as part of the services paid for by real estate taxes.

The Town's contractor for trash, recycling, yard waste and bulk item collections is Con-Serv Industries (CSI). Town street crews provide the brush and fall leaf collections. On occasion, collections don't go as planned, most frequently due to

snow or extreme heat. To keep residents informed about scheduled and unscheduled changes to collections and other Public Works-related news, the Public Works staff offers an e-newsletter. Sign up at www.leesburgva.gov/trash.
