#### **ADDENDUM NO. 1**

### October 20, 2016

Please note the following responses to the questions received:

1. On Page 5, it states: All blanks, except signatures, on the Bid Form shall be legibly completed in ink. If I read correctly, the entire Bid Form is filled out by hand, correct? Does this apply to the copy? Can signatures be photocopied signatures or must they also be originals penned in ink?

ANSWER: The Bid Form has to be completed in ink and signed by someone authorized to bind the company. Bidders can type or handwrite their bid prices, so as long as it is legible. This requirement does not apply to the copy.

2. There is no line item for Emergency Services. Are we to assume that our proposed hourly rate is to be taken as our emergency services hourly rate?

ANSWER: Yes. Please see Section C. Emergency Services on Page 4 of the IFB.

3. Are we allowed to submit documentation other than the 4 required documents?

#### **ANSWER:**

All bidders are required to submit the following documentation with their bid:

- IFB Submission Form
- Reference Form
- Bid Form
- Addenda Acknowledgement
- Copy of certifications for proposed personnel and equipment for work around high voltage power lines
- List of available equipment

Bidders may include equipment or company documentation relative to the bid, but failure to submit the above required documents may deem your bid as non-responsive.

4. Is the estimated hours of 160 the yearly total for this project or is that a monthly estimate of hours for the crew?

ANSWER: 160 hours is the estimated, annual total based upon previous history. These estimated hours are being provided for bidding purposes only. The Contractor will be paid for actual hours performed.

5. What happens to the wood on the tree removals? Is the Town removing it?

ANSWER: At the Town's direction, the wood on the tree removals shall be removed by the Contractor or stump grinded. Please see Section E. Debris on Page 5 of the IFB.

6. What happens if we need a crane for a tree removal and an extra man? Can these costs be added on top of the crew hours?

ANSWER: The Town estimates an annual total of 20 hours for crane usage. The crane shall have a minimum reach of 120 feet and capacity of 36 tons. The use of the crane will be on an as-needed basis at the Town's discretion. <u>Please see the revised Bid Form and use this revised form to submit your bid.</u>

7. Can you please supply me with the previous pricing for this contract?

ANSWER: Although we have added additional requirements in this IFB, for bidding purposes, the previous contract pricing was \$150.89/hour.

Please note the following changes to the contract requirements:

- 8. The following equipment will be required as part of the Tree Maintenance Contract:
  - Bucket/Boom Truck with a 75' reach (forestry bucket required)
  - Stump grinder on track equipment
  - Climbing gear
  - Pruning poles
  - Throwing Ball
  - Rigging Kit
  - Bull Rope
  - Hand lines
  - Outrigger Pads, complete set, non-metal
  - Rake
  - Blower
  - Bush axe

The Contractor shall have this equipment at their disposal and use this equipment at no additional cost to the Town.
