

TOWN OF LEESBURG, VIRGINIA REQUEST FOR QUOTATION

TRAFFIC SIGNAL INSTALLATION ON CATOCTIN CIRCLE AT LOUDOUN RESCUE RFQ No. 100317-FY18-29 March 1, 2018

The Town of Leesburg is requesting written price quotations for the installation of a traffic signal and repair of the communication portion of the signal on Catoctin Circle at the Loudoun Rescue Squad building, as described below. Quotes must be received by 5:00 p.m. ET on Tuesday, March 20, 2018.

Background

As the result of a traffic accident, the traffic signal at the Loudoun County Rescue Squad building on Catoctin Circle was damaged and removed. This contract is intended to install a new traffic signal in the same location.

Scope of Work

The awarded bidder, also referred to herein as Contractor, shall furnish all services necessary to provide, finish and complete the signal work indicated. The work performed under this contract involves the removal of an existing traffic signal foundation, installation of a new foundation, new pole, mast arm, signal heads, and SE-5 electrical service. Also included will be all wiring and communications shown on the bid form. The Town of Leesburg will provide the controller and MMU.

Work hours allowed for this project will be 9:00 a.m. to 3:30 p.m. Monday through Friday. Saturday work will be allowed with permission from the project manager. Some work may have to take place at night and allowable night work hours are 7:00 p.m. to 6:00 a.m. Night work will have to be planned a minimum of two weeks in advance so that all applicable notifications can be given.

Contract Items of Work

Working hours: Work will be allowed during the hours of 9:00 am to 3:30 pm. Some night work may be required.

Testing: Third-party testing is required for all concrete work. The Contractor is responsible for the cost of this testing.

Specifications: All work performed under this Request for Quote shall be performed in accordance with the current edition of the VDOT Road and Bridge Specifications and the current edition of the Virginia Work Area Protection Manual.

Dust Control: The Contractor shall make every effort to control dust on site.

Maintenance of Traffic: This item is to be considered incidental to all other items of work.

Contract Term: This contract is for the stated work only. Contract time will be established on an agreed upon schedule between the Contractor and the Town.

Existing Fiber Runs: There are existing fiber runs that exist from EJB2 that extend towards the W&OD trail and towards Harrison Street. These fiber runs MUST remain functional during and after this project.

- Liability, 1M; combined single limit/each occurrence in the primary policy or through the use of Umbrella or Excess Limits.
- Automobile, 1M; combined single limit per occurrence in the primary policy or through the use of Umbrella or Excess Limits.
- Workers Comp, Statutory.
- Name Town as an additional insured and provide a copy of the additional insured endorsement.

Submission of Ouotes

Bidders are to submit:

- One copy of the attached bid form.
- List of equipment available for performing the work requested.

Negotiations with the Lowest Bidder

Unless all quotes are cancelled or rejected, the Town reserves the right granted by 2.2-4318 of the *Code of Virginia* to negotiate with the lowest responsive, responsible bidder to obtain a contract price within the funds available. Funds available shall mean those funds which were budgeted for this contract prior to the issuance of the written Request for Quote. Negotiations with the low bidder may include both modifications of the bid price and the Scope of Work/Specifications to be performed. The Town shall initiate such negotiations by written notice to the lowest responsive, responsible bidder that its bid exceeds the available funds and the Town wishes to negotiate a lower contract price. The times, places, and manner of negotiating shall be agreed to by the Town and the lowest responsive, responsible bidder.
