This letter serves as your official notification of the action taken by the Leesburg Board of Architectural Review (BAR) at the 16 August 2010 meeting on BAR Case TLHP-2010-0039 for a comprehensive sign plan for the three-building office condo development at 2 Cardinal Park Drive.

As part of the consent agenda, the BAR approved case TLHP-2010-0039 with the clarification that the backgrounds for the cabinet signs will be opaque, with only the text illuminated.

Enclosed is a copy of the approved comprehensive sign plan and the Certificate of Appropriateness; you should keep this material for your file on this project. The COA is void unless work on the approved project has begun within 24 months of the date of approval. Any deviation or departure from or change or modification to the approved plans and specifications approved in this case requires, in all circumstances, prior submission to staff for review and may require further approvals from the Board of Architectural Review. The failure to adhere to these conditions may result in a voiding of the approval and/or enforced remedial action. 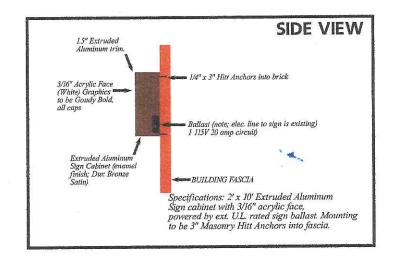

### Comprehensive Sign Plan

No Unit Owner shall sell, lease, rent, loan, exchange or otherwise permit the space outside the Unit Owner's Unit to be used for the erection or maintenance of a sign or placard, by anyone other than the occupant of said Unit (owner of an owner-occupied unit or tenant, if the unit is leased or rented); There shall be no signs displayed except as follows:

## (a) Electric Lighted Signs: Buildings B & C.

There shall be a one time exception to this Section for Buildings B & C for the erection of four signs on the north side of each building (facing Route 7). One sign box is assigned to each unit.

Said signs measuring 2 feet by 10 feet, electric box signs, single faced, with acrylic faces. Faces are Duranotic Bronze #313 with white copy. Boxes are Duranotic Bronze #313. The font on the sign face will be Goudy Extra Bold, all capital letters. [see attachment A]

In the event of a unit vacancy, a matching blank must be inserted in the sign box.

## (b) Electric Lighted Signs: Building A.

There shall be a one time exception to this Section for Building A for the erection of two signs on the west side of the building (facing Cardinal Park Drive). The sign boxes are assigned to Units 106A and 206A. There will be no sign boxes assigned to any other Units in Building A.

Said signs measuring 2 feet by 9 feet, electric box signs, single faced, with acrylic faces. Faces are Duranotic Bronze #313 with white copy, Boxes are Duranotic Bronze #313. The font on the sign face will be Goudy Extra Bold, all capital letters. [see attachment B]

In the event of a unit vacancy, a matching blank must be inserted in the sign box.

#### c) Brass Door Identification signs.

Only permanent signs made of brass with black lettering shall be permitted. [see attachment C)

On the doors installed prior to 1/1/09 said plaques will be five by twenty-four inches. On the new doors installed after 1/1/09 said plaques will be four by twenty-four inches.

### (d) Post / Well Mounted Identification Signs.

Units with a direct outside entrance are permitted one permanent post or wall sign next to said entrance. Said signs measuring 16 to 28 inches (height) by 21.5 inches (width). Various colors on these signs are permitted. [see attachment D]

Units in Buildings B & C may place one Wall Mounted Identification Sign next to the south entrance (facing the parking lot).

Units in Building A may place one Post or Wall Mounted Identification Sign next to said entrance. Units facing the north side may only place said sign on the north side. Units facing the south side may only place said sign on the south side.

#### (e) Window Graphics.

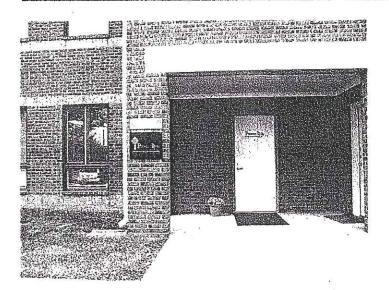
Units in Buildings B & C without a direct outside entrance are permitted to place one window graphic on the glass next to the south entrance (facing the parking lot) of Buildings B & C. Said signs measuring 12 inches by 24 inches. Signs shall be white adhesive mounted to glass.

### (f) Entrance Directory.

The Directory of units at the first entrance, facing Cardinal Park Drive, is the property of the Association. Physical changes can be made to this sign only by the Association Board of Directors. No Unit Owner may remove or take any of the inserts for this sign

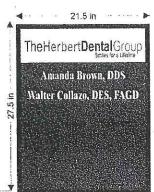


Sample Layout A

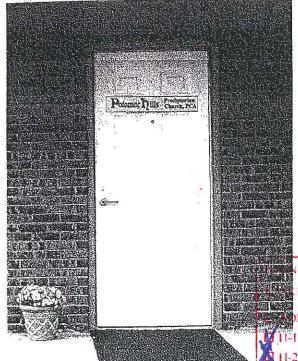
