**A RESOLUTION:** AWARDING A CONTINUING SERVICES CONTRACT FOR PROFESSIONAL AIRPORT PLANNING, ENGINEERING, AND ARCHITECTURAL SERVICES FOR THE LEESBURG EXECUTIVE AIRPORT TO TALBERT & BRIGHT & KANE, INC.

WHEREAS, in response to a public solicitation for continuing services for Professional Airport Planning, Engineering, and Architectural Services for the Leesburg Executive Airport, four proposals were received from the following firms:

Campbell & Paris Engineers, P.C.	Parrish and Partners, LLC
Delta Airport Consultants, Inc.	Talbert & Bright & Kane, Inc.

WHEREAS, the proposals were evaluated by an evaluation committee in accordance with the Town's procurement policy, and the requirements of the Request for Proposals; and

WHEREAS, the evaluation committee selected Talbert & Bright & Kane, Inc. to be the top ranked firm; and

WHEREAS, the continuing services contracts for Professional Airport Planning, Engineering, and Architectural Services for the Leesburg Executive Airport will be for an initial period of one (1) year, and renewable for up to four (4) additional consecutive periods of one (1) year; and

WHEREAS, continuing services for Professional Airport Planning, Engineering, and Architectural Services for the Leesburg Executive Airport are to be provided on a project-by-project basis, and each task order will be less than \$500,000; and

WHEREAS, the total aggregate amount of the task orders shall not exceed \$1,500,000 per year per contract; and

WHEREAS, the Director of Public Works & Capital Projects, the Airport Director, and the Airport Commission recommend award of the continuing services contracts for Professional Airport Planning, Engineering, and Architectural Services for the Leesburg Executive Airport to Talbert & Bright & Kane, Inc.


