New Business:

- Alcohol Policy The Commission was briefed on staff steps to remove the 5:00pm time restriction for the serving of alcohol within P&R facilities. The following motion was passed 4-0-2. "The Parks and Recreation Commission endorses staff's recommendation to remove time restrictions from the Department's Policy for Alcohol use at Town Facilities and Town Produced Events."
- <u>Park Plaques</u> The Commission requested that funding for 7 individual park plaques at \$5,000 each be provided within the Parks and Recreation Commissions FY23 budget for a total of \$35,000. Each plaque is intended to tell the naming history of individual park sites.
- <u>Departmental Information</u> The Commission was briefed on departmental performance during the past month and any upcoming events.
