1. *Approval of Minutes:* On motion by Jeff Phillips, seconded by Mark Norman, the Commission approved the May 2, 2022, minutes.
2. *Public Comments:* Mrs. Christina Budzier, resides at the intersection of Wage Dr. and Dry Mill Road. Concerns about excessive speeding. Ongoing and dangerous situation. Additionally, concerns with inattentive drivers. All times of day, both directions. Request traffic study and possibly some type of traffic calming on Dry Mill Rd. Chairman Grossman requested review of any previous studies on Dry Mill Road. Speeding has been an issue, and Chairman Grossman requests LPD get a speed study.
3. *Smart Trailer results:* Sgt. Martin reported, several complaints about Memorial Dr./West Market St. about speeding, high volumes. LPD did not observe any speeding on Memorial Drive. Volumes high in the morning coming into Leesburg and, interestingly, not as high in the opposite direction in the evening. LPD will be meeting with citizens to discuss situation and report back to RTC.
4. *Traffic Calming South King at Bike Path:* RTC suggested flashing beacons, signage, rumble strips on trail. Trail belongs to NOVA Parks. Issue: Bike/peds sometimes do not follow protocols, but signals, ped/bike yields can be confusing also. Problems exacerbated by the opening of Goose Cup at South Street. Town staff to have recommendation at the July 11, 2022 meeting. Requested by Councilmember Ara Bagdasarian.

5. Tavistock Dr. at Duncan Pl./Curtin Pl. Intersection: The Town received email from citizen Gabe Valdez, expressing concerns at Tavistock Drive at Duncan Place/Curtin Place: Town staff to review intersection and report back to RTC at the July meeting.
