- Outdoor Performance Stage The Commission was provided the presentation given to Council regarding a
 potential outdoor performance stage at Ida Lee Park. The Commission provided the following
 recommendation on a 6-0-1 vote: "The Parks and Recreation Advisory Commission is in support of the
 concept of a performance stage. However, we do not feel that the current park system inventory meets
 the need for such an amenity at this time. We believe there may be opportunities to obtain land within
 Town limits for this resource in the future."
