Call to Order: The Meeting was called to order by the Chairman at 6:00 p.m.

Approval of Minutes: Regular meeting minutes of March 8, 2023 were approved (7-0-1).

Petitioners and Public Input: none

Old Business:

- <u>Air Traffic Control Tower</u>: The airport director shared a presentation from this week's town council meeting. The presentation updated the Commission on efforts and communications with the FAA regarding the end of the remote tower program and extension of air traffic services. The FAA has agreed to bring a mobile air traffic control tower back and fund staffing through September 30, 2023. Funding opportunities for tower construction are available.
- <u>Apron Paving Projects</u>: The airport director updated the Commission that two paving projects will cause disruption to aircraft hangars and parking. The south apron project phasing plan has been revised to reduce overall impact to airport businesses and hangars. The project will still cause aircraft to be temporarily relocated as tie-down areas are paved.
- <u>Security Improvements</u>: The airport director shared information on security enhancements that are in progress. The major improvements include replacement of the airport's card-access control system. The new system will work with the town's system for consistency, reliability, and easier access for police officers. A CCTV system that will integrate cameras town-wide is under solicitation at this time.

New Business:

None.

Reports:

- <u>Airport Director</u> The airport director provided updates on the monthly report. A significant number of residents from Evergreen Meadows are reporting increased noise. The airport staff will work on potential mitigations measures for discussion.
- FBO Comments John with Kuhn Jet Center inquired about weight capacity for aircraft overflow parking at the new north-end apron.
- <u>Airport Business Association Comments</u> Mr. Fisher did not have any new updates from the ABA
- <u>Chairman's Report</u>: The Chairman discussed the tower issues and priorities.
- Committee Reports:
 - Operations: Mr. Forsythe noted the operations committee is working on outreach regarding the remote tower and will work on noise issues.
 - Land Use and Development: The airport director noted that there is a new landdevelopment application for a data center or distribution center south of the airport.
- Commission Member Comments: Mr. Silvey discussed the town's strategy regarding the remote tower particularly that the town should push the FAA harder to preserve the remote tower as it is currently operating. The airport director did not disagree that users or interest groups may still inquire with the FAA and Saab regarding decisions made to cancel the JYO remote tower system. However, the town lobbyist and staff are focused on working with the FAA to preserve air traffic control services at JYO, even if in traditional facilities.
- <u>Board of Supervisors Representative Report</u>: Mr. Corcoran did not have any new information to report.

- <u>Final Petitioners and Public Comments</u>: Mr. Gallagher appreciated the efforts to preserve air traffic control services.



Noise Complaints (54 from 3 households)

- 49 complaints from Balch Spring Circle (noreply@gmail.com) most reporting multiple touch & go traffic over Evergreen Meadows. For example "N6128E is now performing stop and go's, starting at 9:19pm and continuing until now (9:35pm; ongoing). Having multiple overlapping planes performing touch and go's / stop and go's while the air traffic control tower is not operating is an unacceptable risk, in addition to producing an unreasonable noise disturbance late in the evening over residential neighborhoods. From both a safety and noise/disturbance perspective, this is not unreasonable. Touch and go's should be banned at JYO."
- <u>4</u> complaints from 105 Balch Spring Circle opposed to multiple touch and go's and environmental pollution. Represents HOA and seeking alternative flight paths/mitigation. Late night touch & go (addressed with school).
- <u>1</u> complaint from 1205 Athena Dr. in Meadowbrook due to 11:43pm touch and go—addressed with school operator.
