

Town of Leesburg Environmental Advisory Commission Meeting Minutes October 10, 2023

The Town of Leesburg's Environmental Advisory Commission (EAC) met on October 10, 2023, at 7:00 p.m. in the Town Hall at 25 West Market St., Leesburg, Virginia.

Call to Order: Chair Sheaffer called the meeting to order at 7:06p.m.

Staff Items:

- **Sustainability Report:** Ms. Moran presented to the Town Council on October 3rd on three different topics. 1) Sustainability, GHG, etc. 2) Food waste composting, 3) Solar on public buildings. We discussed a pilot program for food waste drop off and the location. We will discuss more during our next meeting.
- Updates to Board and Commission Rules. See two emails from Eileen Boeing.
 Commissioners will only be paid for meeting they attend. Commissioners are limited to electronic participation two times per calendar year, and must arrange ahead of time.
 Review and update Bylaws next meeting per request from Glick.
- EV Charging for Multifamily Communities. Talked about Town Manager ermail on Charge-up Fairfax. EV in LMI Housing working with Dominion Resources. Cover up to half. Owner of the property controls the fees. We will vote on next month.
- Reminder of our \$3,500 budget discuss spending plan next month

New Business:

- Road Salt. Toolkit available from NoVA regional commission. SAMS toolkit. Mostly about promotion to residential sector. Do's and Don'ts. What you should use. Raises cost of water treatment. Consider public outreach campaign
- Lantern Fly and Tree of Heaven. Discussion and working with Tree Commission
