  - O Potassium permanganate product analysis indicating % KMnO4, sieve analysis, density, specific gravity.
  - o Most current SDS Report for each chemical being bid by your firm.
- Bid Opening:
  - o At the bid due date/time, a public bid opening will be held via Microsoft Teams
- Award criteria
  - The Town anticipates multiple contract awards resulting from this solicitation. The Town intends to award contracts to the lowest and second lowest responsive, responsible bidders per bid line item who are authorized to transact business in the Commonwealth of Virginia with demonstrated experience similar in nature to that being requested herein.
  - o During the contract period, the Town will order chemicals from the lowest bidder for the applicable chemicals.
  - Should such chemicals be unavailable from the lowest bidder, or delivery cannot be provided in a necessary timeframe that is acceptable to the Town, the Town will order such chemicals from the second lowest bidder for the applicable chemicals.

# ITEM NO. 3: PRE-BID MEETING SCOPE OF WORK DISCUSSION

The Town's Utilities Project Manager described the scope of work as listed in the IFB:

• The Town of Leesburg is accepting sealed bids from qualified firms to furnish and deliver various water and wastewater treatment chemicals described herein. Delivery will be to either the Town's Water Treatment Plant located at 43234 Edwards Ferry Road, Leesburg, VA 20176, and/or the Town's Water Pollution Control Facility located at 1391 Russell Branch Parkway, SE Leesburg, VA 20175. Firms are not required to bid on all chemicals (all line items). Partial bids are acceptable.

Bidders must take due notice and be governed accordingly. This addendum must be acknowledged as indicated in the Invitation for Bid or your bid may not be considered.
