Chair Vanderloo: I hereby call this Town of Leesburg Board of Zoning Appeals, January 16th, 2024 meeting into session. Ashleigh, would you please take the roll?

Ms. Goedeke: Yes. Chairman Vanderloo?

Chair Vanderloo: Present.

Ms. Goedeke: Vice Chair Moffett?

Vice Chair Moffett: Present.

Ms. Goedeke: Mr. Gutierrez?

Mr. Gutierrez: Present.

Ms. Goedeke: Ms. Semmes?

Ms. Semmes: Present.

Ms. Goedeke: Mr. Marshall?

Mr. Marshall: Present.

Chair Vanderloo: All right. Thank you for that. I determine that we have a quorum present. All five of our members are present, so we can conduct the business that we were brought together to conduct tonight. We have just a few items on the agenda. We're going to have a couple meeting minutes, September 19th, 2023, December 19th, 2023. There is no public hearing, as we know. I'm not aware of any unfinished business, but when I get to that, I'll call for any.

Then we definitely have the new business for the election of officers, the adoption of the 2024 meeting calendar, and then also the adoption of the beautiful, well-done, professional 2023 BZA Annual Report. Vice Chair Moffett: I think that was really the only thing I noticed and I just would like to bring it up. As far as Ms. Arnett's report, I'm counting them. That way, I can check to see if that's exactly what she said.

Mr. Marshall: I'll second that.

Chair Vanderloo: Thank you. I accept. Thank you. Any other nominations for chair? All right. Hearing none, I'll call for nominations for vice chair. I would also like to nominate you for vice chair, Ms. Moffett.

Vice Chair Moffett: I accept.

Ms. Semmes: I would second that.

Chair Vanderloo: Fantastic. Any other nominations for vice chair? All right. Hearing none, I'll close the nominations and move to vote. All in favor of electing Peter Vanderloo as chairman, Susan Moffett as vice chairman, say aye.

Members: Aye.

Chair Vanderloo: Any opposed? All right. Peter Vanderloo and Susan Moffett are hereby elected as chair and vice chair, respectively. All right. Thank you for that. The next item is the adoption of the 2024 BZA meeting calendar. Did everybody receive a copy of the BZA meeting calendar? Does anybody have any comments to this?

Vice Chair Moffett: The business meetings are January-- For some reason, I thought it was up to January and September. Which of those--

Ms. Goedeke: Yes, it's January and September.

Vice Chair Moffett: January and September.

Ms. Goedeke: That's been typical the last couple of years.

Vice Chair Moffett: Oh, that's why the asterisks are there, obviously. Yes, I see it now.

Ms. Goedeke: Yes. They're bolded. January 16th and then September 17th are our two regularly scheduled meetings.

Vice Chair Moffett: The others would just be as needed.

Ms. Semmes: As needed.



Vice Chair Moffett: Right.

Mr. Marshall: It's just those two?

Vice Chair Moffett: Just those two that we meet regardless of whether we have a case or not.

Chair Vanderloo: In reviewing the December meeting minutes, I understand that there may be something coming soon so we may have a meeting.

Ms. Goedeke: On the agenda for this one, I think April is what we estimated for another update from Ms. Betsy Arnett for the zoning ordinance rewrite is about that timeframe when we expect her to come-

Chair Vanderloo: Okay, fantastic.

Ms. Goedeke: -to come back to the board and offer a presentation.

Chair Vanderloo: There may also be something in the downtown, a contested--

Mr. Watkins: We'll see. The council is entertaining an amendment to the zoning ordinances, which may preempt the need for variance, so we'll see what happens with that.

Chair Vanderloo: All right. We shall tune in with excitement to see how this comes out. All right, back to business. I'm sorry. I was trying to keep you warm.

Vice Chair Moffet: Thank you. [crosstalk] are thawing out.

Chair Vanderloo: Hearing no comments, I will entertain a motion for the approval of the adoption, I should say the 2024 BZA meeting calendar.
