Call to Order: The meeting was called to order at 7:04 p.m.

Approval of Agenda

 Agenda was approved as presented, on a motion by Commissioner Segura, seconded by Commissioner Simonetta.

Approval of Minutes

• The minutes of the March 13, 2024, regular meeting were approved as presented, on a motion by Commissioner Horvatinovich, seconded by Commissioner Simonetta.

Commissioner Comments

• Commissioner Gonzalez said he wanted the Commission to take the next step in addition to meeting monthly and begin working on plans in line with some of the goals and objectives set in January.

Staff Report

 Ms. Rodriguez gave a brief update on behalf of the Leesburg Police Department since Sgt. Abilmona was not able to be present. She noted that the annual Fiesta Latina event was being re-themed and the Police Department was eager for the Commission's partnership. She also noted that she'd like to get a picture of the Commissioners together.

New Business

- Bablic Language Translation Plug-In: With the announcement by Ms. Rodriguez that the
 Town Council had approved the Commission utilizing its remaining Fiscal Year 2024
 funds to begin using the Bablic subscription on the Town website, Commissioners
 discussed what seven languages should be available for translation. Ms. Rodriguez
 presented data from Town staff and the U.S. Census Bureau regarding what languages,
 outside of English, are predominantly discussed by household members in Leesburg.
 After discussion and input, the Commission decided to include Spanish, French, Korean,
 Chinese, Arabic, Tagalog, and Farsi. The Commission also offered feedback on a
 translation assistance poster developed by Town staff.
- Boards and Commissions Networking Event PowerPoint Presentation: Commissioners
 reviewed the PowerPoint presentation used in the 2023 Boards/Commissions
 Networking Event. Several changes were offered, with Commissioners Gonzalez and
 Horvatinovich electing to work together following the meeting for any additional
 changes. Commissioners also noted if they would be able to attend the April 29 event.

Other Business

Commissioner Segura solicited interest in the Commission participating in the May 5
Loudoun Latino Festival. Commissioner Gonzalez said if the Commission offered
facepainting again his daughter could help. Ideas for swag and Commissioner T-shirts
were shared for future events. The Commission voted to utilize \$100 of existing Fiscal
Year 2024 funding to purchase facepainting supplies for the event. Ms. Rodriguez said
she would take that request to the Town Manager.
