## **Approval of Agenda**

#### **Old Business**

• National Night Out (debrief): Commissioner Horvatinovich said the tattoos offered by the Commission were a hit, and all who attended enjoyed themselves. Ms. Rodriguez shared the Police Department's contentment with the event.

#### **New Business**

• **Q&A with Sydney Aquilina:** Sydney Aquilina, a member of the local Indigenous community, gave an overview on Indigenous Peoples of Virginia, and also spoke about

- her advocacy for a local statue project. Commissioners asked questions and shared thoughts.
- **Fueled Snack Drive:** Ms. Rodriguez gave a brief update on the upcoming snack drive to benefit Fueled. She said a news release would go out after Labor Day for the drive, which will run from September 9 through 20. She will reach out to Fueled staff for coordination.
- **Employment Fair:** Ms. Rodriguez asked for additional guidance on job fair digital advertising and other outreach efforts. The Commission will decide on staffing the job fair at the September meeting.
- Awareness Displays/Proclamation Requests: Ms. Rodriguez said she had added this to the agenda as a discussion point in case the Commission wished to recognize any upcoming awareness months or causes. Commissioner Quijano suggested the Commission endorse an awareness display application to recognize October as Domestic Violence Awareness Month to illuminate the Town Hall façade purple during that entire month. A suggestion was made to invite LAWS to the September meeting, and to consider putting together a First Friday event in October to honor the month and to bring awareness to the issue of domestic violence. Commissioners Quijano and Borg offered to be the main points of contact with Ms. Rodriguez. All present voted to request the awareness display and event application.
