Call to Order: The meeting was called to order at 7:05 p.m.

Approval of Electronic Participation

 On a motion by Commissioner Segura, seconded by Commissioner Horvatinovich, Commissioners Simonetta and Borg were approved to participate in the meeting electronically due to logistical issues.

Staff Report

Ms. Rodriguez reminded the Commission that the snack drive to benefit Fueled was
ongoing through September 20, with donation bins at Town Hall and Ida Lee Park
Recreation Center. She gave an update on issues with Bablic functioning correctly on the
Town website. She also reminded the Commission that Chief Pirnat would be attending
the October 9 and asked if there were any objections to putting her presentation at the
beginning of the meeting and saving event/initiative debriefs to later in the agenda. She

- also let the Commission know that they would need to begin discussing their FY26 budget request as that vote would need to occur at the November meeting.
- Sgt. Abilmona noted that National Night Out went very well.

- Q&A with LAWS: LAWS CEO Sam Clarke and Volunteer & Outreach Coordinator Leighanne Greenberg gave an overview of the services provided by LAWS Domestic Violence & Sexual Assault Services. Commissioners asked questions and offered feedback.
- **Domestic Violence Awareness Month Ceremony:** Commissioners and LAWS representatives discussed planning and coordination for the October 4 Domestic Violence Awareness Month Ceremony.
- Employment Fair: Ms. Rodriguez offered an update on the job fair digital advertising campaign and confirmed employers. Commissioners discussed who will attend the event. On a motion by Commissioner Segura, seconded by Commissioner Horvatinovich, the Commission voted to request \$20 in funding to purchase water bottles for attendees and exhibitors.

Commissioner Segura asked if there was interest in the Commission sponsoring a
proclamation to recognize Hispanic Heritage Month. On a motion by Commissioner
Segura, seconded by Commissioner Horvatinovich, the Commission voted to submit that
request to the Town Council, and Commissioner Segura offered to accept it at the
Council meeting.
