Application is hereby made for a permit to perform the work as shown on the accompanying plan or sketch attached hereto. Said work will be done under and in accordance with the rules and regulations of the Town of Leesburg, so far as said rules are applicable thereto and any other agreement between the parties hereto. Where applicable, said agreement shall be attached and made a part of this permit assembly including any cost responsibilities covering work under permit. Applicant agrees to maintain the work from the time of completion until final inspection for acceptance is made by the Town of Leesburg. Applicant also hereby agrees and is bound and held responsible to the owner of any and all existing facilities for any and all damages to any other installations already in place as a result of work covered by this permit. Applicant shall indemnify and hold harmless the Town of Leesburg and all town employees, agents, and officer, from responsibility, damage, or liability arising from the exercise of the privileges granted in this permit. In consideration of the issuance of this permit, the Permittee agrees to waive for itself, successors, interest or assign any entitlements it may otherwise have to have hereafter under the Uniform Relocation and Assistance Act of 1972 as amended in the event the town or its successor, chooses to exercise its acknowledged right to demand or cause the removal of any or all fixtures of whatever kind or description that may hereafter be located pursuant to this permit. The Town of Leesburg reserves the right to revoke this permit if the conditions of the permit are not satisfied as described herein.

**This permit is invalid after the date of expiration & will be cancelled unless an extension of time has been requested. An extension of time will not be granted unless work is actually under way. This permit may be extended by making written application to the Town, at least 5 days prior to the date of expiration. If permit expires before work is complete, a \$100.00 reinstatement fee must be paid before final inspection & release can be made.**

- Notice shall be given to "Miss Utility" at 1-800-257-7777 or the Town of Leesburg for traffic signal location at 703-771-2790 and all clearances secured before excavating.
- Notice shall be given to the DPW 24 hours prior to beginning proposed work. Contact Inspections at 703-771-2782.
- Scaffolding or ladders placed over sidewalk must provide 7'0" minimum headroom clearance and fully protect pedestrians from the danger of falling material.

**NOTE: THIS PERMIT MUST BE KEPT ON THE WORK SITE** and shown when requested. All traffic controls shall be planned and executed in accordance with the Virginia Work Area Protection Manual and the Manual on Uniform Traffic Control Devices for Streets and Highways, current editions, and special instructions given by the Traffic Engineer. All work shall be performed in accordance with the Town of Leesburg Design and Construction Standards Manual (DCSM) and the Virginia Occupational Safety and Health Standards for the Construction Industry (VOSH).
