ITEM NO. 1: PRE-BID MEETING INFORMATION

A non-mandatory pre-bid meeting was held on Tuesday, February 16, 2021 at 10:00 a.m. via Cisco Webex.

During the meeting, several questions were asked and answers were provided as follows:

1. Clarification was requested for the professional survey/surveyor requirement.
RESPONSE: A surveyor is not required; rather, the Contractor should coordinate with the Town's site supervisor during installation.
2. Clarification was requested regarding the Maintenance of Traffic (MOT) requirement.
RESPONSE: Contractors must follow the Virginia Work Area Protection Manual (VAWPM). The MOT will be part of the Town's Right of Way permit submittal.

3. Clarification was requested regarding soil testing requirements as noted on the plans.
RESPONSE: Soil testing is not required as part of this contract.

1. Question: We are having some issues locating a source for some of the plant material listed in the bid. Can you provide a source for these plants or a substitution? We do not have source for Quercus pagoda Cherry Bark Oak , Amelanchiar x grandifolia Coles Select Serviceberry Coles Select and Ostrya virginiana Hophornbeam?

- Line 11: American hornbeam (Botanical Name "Carpinus caroliniana"), 2" Caliper, Potted or B&B
- Line 12: Autumn Brilliance Serviceberry (Botanical Name "Amelanchiar x grandifolia 'Autumn Brilliance'"), 2" Caliper, Potted or B&B
